

## Members Only Conference Room Logo Display Agreement



Another great way to promote your business is by displaying your logo on the wall in the “Grand Chamber” conference room at the Plano Chamber of Commerce. With approximately 7,000 impressions annually through events such as BI, Board of Directors meetings, Leadership Plano, Ambassadors Meetings, New Member Meetings, Success In Business, and other rentals and meetings, your investment comes out to about 1.8 cents/impression, which is a great value to you!

The price is **\$125** for one year if you are a new customer or if the logo that is currently on display needs to be redesigned. Each logo will fit into an area of 12”x12” white square. If you are renewing and there is no change to your design, the price is only **\$100** for one year.

The preferred file format for logos is **Vector EPS, PDF** or **AI** (make sure any fonts are outlined). Bitmap files may also work, but become grainy as they are enlarged and are frequently unacceptable at full scale. A good rule of thumb is at least 500KB for a logo this size. If you need to have a logo created or recreated, Signs By Tomorrow will call you with an estimate. You will be solely responsible to them for any additional agreed upon costs incurred, not the Plano Chamber of Commerce.
